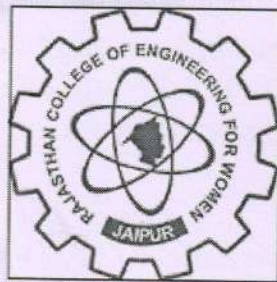

- a) **SOHA Technologies Pvt. Ltd.** has agreed to conduct **In-House Training on Python** at the premises of **RCEW, Jaipur**. **SOHA Technologies Pvt. Ltd.** will deliver both theory and practical.
- b) **RCEW, Jaipur** has agreed to provide, lab infrastructure (covering training space with sufficient virus free computers and projector etc.) required for training.
- c) **RCEW, Jaipur** will provide minimum **45 to 60 students** from Computer Science Engineering Branches .The duration of Training will be decided as per the mutual understanding between both Parties. Fees Collection from the students will be the responsibility of college.

- f) **The mode of payment will be as follows:**

 - 30% amount will be payable at the mid of the training
