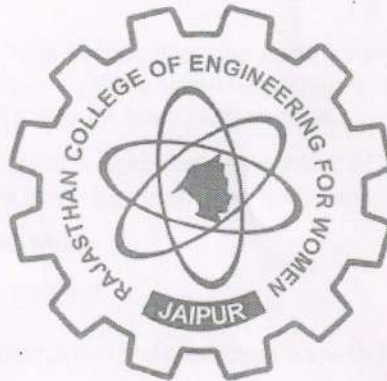

1.0 BACKGROUND

Jaipur Yoga League (herein referred to as "JYL") is a society based in Jaipur, India which works on improving health awareness among citizens of India through regular yoga camps. JYL is also engaged in training professionals and creating facility centres for promotion and establishment of yoga as a essential part curriculum in schools & colleges. JYL is also engaged in providing customise boot camps on commercial basis in schools & college.

Rajasthan College of Engineering for Women (Jaipur, Rajasthan) (herein referred to as "RCEW") has been established with the vision of becoming one of the world's leading engineering institutes in both educational and research and achieve greater recognition for our efforts in our chosen fields of endeavour. The college will build on its traditions of innovation, problem solving, and interdisciplinary collaboration to meet the changing needs of the society.

PURPOSE & SCOPE

The purpose of this MoU is to collaborate in building a healthy and fit generation of technocrats who will not only be good professional but also mentally and physically fit citizens. Among other purpose and scope of this MoU both parties intended to make students healthy both mentally and physically. This programme will be implemented in a manner that both parties will work together to attain the expected end results from this collaboration.

JYL shall provide its training to students belonging to all of branches and year in RCEW campus as identified by the college management.

RCEW is allowed to use Jaipur Yoga League logo and name to promote yoga among its students and other organisations related to RCEW jaipur, similarly Jaipur Yoga League will also be allowed to use the logo of RCEW on its website and other material purely for advertising purpose.

Both parties shall NOT make any financial commitment on behalf of each other, nor shall take loans or create any other financial liabilities which are binding on each other under this agreement.

2.0 JYL RESPONSIBILITIES UNDER THIS MoU

3.1 JYL shall undertake the following activities:

3.1.1 Maintain the quality of instructors and instruction material (if any).

3.1.2 Provide norms and guidelines wherever necessary

3.1.3 Train the personnel from RCEW and enable them to handle the on-ground situation at the college.

3.1.4 Shall ensure through proper co-ordination and consultation that all the Trainings provided ensure life changing skills.

3.0 RCEW RESPONSIBILITIES UNDER THIS MoU

4.1 On its part the RCEW shall undertake the following activities:

- 4.1.1 Shall provide administrative facilities to implement the disciplined and time-bound approach.
- 4.1.2 Shall arrange local requirements for smooth completion of course .
- 4.1.3 Shall provide the required minimum infrastructural facilities like yoga ground, mats, PA systems.

5.0 INTELLECTUAL PROPERTY

JYL will hold all the rights of their course materials and training process. RCEW can anyhow suggest content changes based on the student requirements.

6.0 AMENDMENT AND MUTUALLY UNDERSTOOD BETWEEN THE PARTIES

This is a MoU that guides the relationship between the two parties towards solving the challenges healthy lifestyle in RCEW to have effect, any modification on aspects of this MoU will be by the written consent of both parties. Agreed upon projects/programmes will be agreed upon separately and form part of this MoU as annexes. Activities will be drawn up accordingly, which will include additional responsibilities and timelines.

7.0 PERIOD OF VALIDITY

This agreement shall be initially valid for three year from the date of signing the agreement and to be renewed subsequently by mutual consent of both the parties.

8.0 PRICING

Pricing will be decided on mutually agreed terms between Jaipur Yoga League and the RCEW depending on the number of students, course duration and validity.

9.0 EFFECTIVE DATE AND SIGNATURE

This MoU shall be effective upon signatures of both JYL and RCEW officials.

10.0 TERMINATION OF THE MoU

Termination of this MoU will be by mutual consent and in writing to either party.
