NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1

CO-OPERATION

- 1.1 Both Parties are united by common interests and objectives, and they shall establish co-operation.
- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities.

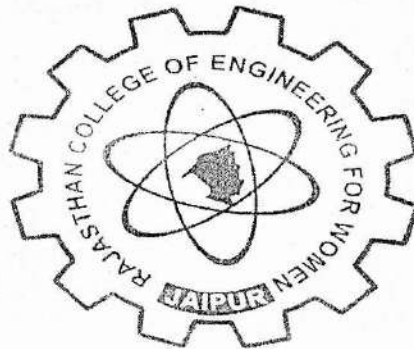

Memorandum of Understanding

Dasan Road, Alwarpet, Chennai 600 018 (hereinafter referred to as Garuda Aerospace) OF THE ONE PART and RCEW an educational institution situated at its registered office at Bhankrota, Ajmer Road, Jaipur OF THE OTHER PART, with a mutual desire to cooperate on bringing Industry interface by providing programs/certificate courses which are in line with the strengths and aspirations of both the organizations.

The expressions Garuda Aerospace and "RCEW" shall, wherever the context admits, mean and include their respective successors in interest and permitted assigns. This MOU is executed at Chennai in the _____

WHEREAS

- Garuda Aerospace with an objective of bringing industry interface to students of RCEW
- Garuda Aerospace Pvt Ltd, India's Drone Unicorn start-up is shaping the drone ecosystem in India by pioneering applications in multiple domains using drones. Garuda Aerospace is the India's largest Agriculture Drone fleet owner with a thirst to provide newer solutions for multiple challenge statements with drones as a platform for the solution.
- Garuda Aerospace is willing to participate in an arrangement with RCEW for providing Industry Interface to the students of the RCEW as preferred partner.
- This MOU provides for Garuda Aerospace and RCEW to come together for mutually beneficial cooperation on Industry Interface of Drones as mentioned below;

NOW THEREFORE THIS MOU WITNESSETH AS FOLLOWS:

1. Objectives:

The objective of this MOU is to combine and synergize the expertise of Garuda Aerospace and RCEW. Both the parties shall commit the necessary resources in pursuance of the objectives and formulate necessary action plan to fulfill the objectives. Both the parties undertake to work with each other in a seamless and transparent manner in the spirit of mutuality and partnership.

2. Areas of Cooperation:

This MOU addresses mutual cooperation in the following areas:

- (A) Research and Development
- (B) Training
- (C) Service and Maintenance
- (D) Advisory role in academics (Drone Technologies)

Garuda's Commitment

- Garuda Aerospace Centre of Excellence (CoE) at the RCEW engages faculty and students of the institute in research, consultancy, service & maintenance of Drones and training programs/certificate courses.
- Provide inputs to enhance the curriculum and be an advisory from the capacity of an industry expert in Aeronautical field (Drones).
- Provide RPTO licensed training to students and faculties of the Garuda Aerospace Centre of Excellence (CoE) of RCEW, on commercial basis. Theory and simulation training will be conducted at the RCEW, while flying training will be conducted at Garuda Aerospace, Chennai.
- Provide internship opportunities to the students of RCEW.
- Provide placement opportunity to the students of the Garuda Aerospace Centre

of Excellence (CoE), if found eligible, he/she will be hired to the team as per their interest and capabilities. Conducting National Drone Events/Competitions for the students of Garuda Aerospace Centre of Excellence (CoE) at RCEW yearly.

RCEW Commitment

- Provide civil, electrical and computing facilities for the Garuda Aerospace Centre of Excellence (CoE).
- Shall nominate two faculty members preferably in the grade of Asso. Professors and above, to undergo 5 day training program at any of Garuda Aerospace's facilities. This training program shall be offered at free of cost. Food and Accommodation to be borne by the RCEW. These two faculty members shall maintain and operate the Garuda Aerospace Centre of Excellence (CoE) as per the policy and guidelines defined by Garuda Aerospace. No honorarium or salary shall be paid for such activities.
- Provide accommodation and hospitality at subsidized rates from RCEW to the trainers and experts from Garuda Aerospace during training and consultancy activities. Provide accommodation (subject to availability) and hospitality for external trainees on a paid basis
- RCEW will provide Advisory Services through our faculties who are trained in this domain once the MOU is executed and operationalized.
- Act as a service centre of Garuda aerospace and render repair and maintenance to the clients of Garuda aerospace

3. Non-Exclusivity:

The cooperation/understanding contemplated herein is not exclusive and GARUDA AEROSPACE/RCEW shall be free to enter into similar arrangements with any other party also.

4. Exercising Authority:

Both GARUDA AEROSPACE and RCEW will nominate and inform to each other names of two specific representatives to act as the exercising authorities, for operating the various provisions of this MOU on behalf of their respective organizations. All formal communications will be exchanged only through these nominated representatives.

5. Validity of this MOU

This MOU shall be valid for a period of 3 years initially from the date of signing, after which it can be renewed by mutual agreement between the parties. Either party during its currency can also terminate this MOU by giving a notice of one month on the other. On termination, each party shall return to the other party all such documents and reference material as may have been borrowed for the purpose of fulfilling the work under this MOU. This MOU shall also stand terminated if a court of competent jurisdiction declares either of the parties as insolvent. Any termination as per this clause shall not affect the antecedent liabilities of the parties prior to the termination including completion of all assignments that have been agreed prior to such termination.

6. Confidentiality:

In the course of fulfilling the mutual responsibilities under this MOU, there will be a sharing of information of confidential nature. Both parties hereby agree to maintain such information relating to methods, trade secrets, products, services, processes, techniques and other proprietary information in strict confidence and not divulge these to any third party without the express consent of the other party except as may be necessary in the course of fulfilling mutual responsibilities in this MOU. This clause of confidentiality shall extend to the parties employees and associate / Subsidiary Companies / Concerns.

The parties each agree to refrain from distributing, disclosing or disseminating the Confidential Information of the other party and its affiliated entities which is disclosed to it and its affiliated entities in any manner to any person or entity except to the Recipient's employees, consultants and agents who have a need to know and who are obligated in a manner consistent with this MOU to maintain the confidentiality of such information.

Each party's obligation to maintain the confidentiality of the Confidential Information of the other party shall expire two (2) years after the date of disclosure or 12 months after expiry or termination of this MOU whichever is earlier. All drawings and other documents, any copies thereof, or things or samples which embody the Confidential Information of a party shall remain the property of that party and will be promptly destroyed, upon that party's request. The parties each agree that the Recipient of Confidential Information shall not remove any copyright, confidential, proprietary rights or intellectual property notices attached to or included in any Confidential Information furnished by the other. The Recipient shall reproduce all such notices on any copies.

The restrictions and confidentiality obligations set forth in this MOU shall not apply to the Discloser's Confidential Information which:

- a) is disclosed upon the advance written authorization of the Discloser;
- b) is lawfully disclosed to the Recipient by a third party without any confidentiality obligation; or
- c) is clearly demonstrable that same was lawfully known or independently developed by the Recipient prior to such disclosure.

Neither party shall use the Confidential Information of the other for any purpose other than to carry out the purpose of this MOU.

The Receiving Party shall construe nothing contained in this MOU as granting to a party a license, either express or implied, under any patent or copyright owned or obtained, or which

is or may be licensable.

Neither party shall make any press release or other public references or utterances of any kind regarding this MOU, the information received as part of this MOU or the contents of this agreement without prior written consent of the other party.

Each party upon written request from the other party shall return or destroy all drawings and other documents, including any copies or summaries thereof, or other tangible forms which embody any confidential information of the requesting party.

7. Notices:

All notices and communications concerning this MOU shall be sent to the respective addresses of the parties as below

8. Amendments:

Any amendments to this MOU shall be in writing and signed by both the parties.

9. Ownerships:

Intellectual property rights, titles or ownership of any products, proprietary information or technology will not be transferred from one company to another on account of use of the same as part of any work under this MOU and shall always remain with the original owner of the same.

10. Costs:

RCEW shall bear their respective costs arising out of the imparted Industry Interface programs/certificate course under this MOU.

Revenue generated out of this agreement viz. training, MRO operations and advisory services shall be shared between the parties as mutually agreed upon through a separate addendum to this agreement.

11. Detailed agreement:

The parties will enter into a detailed agreement for each module materialized under this MOU.

The detailed agreement shall outline roles and responsibilities, liabilities to customers and define primary and secondary responsibilities for each business assignment to be executed.

The detailed agreement shall not override the MOU, but define a commercial and contractual framework for work execution.

12. Commitments:

RCEW/GARUDA AEROSPACE shall make commitments or bind RCEW /GARUDA AEROSPACE in any manner with any customer only with prior written consent from RCEW/GARUDA AEROSPACE.

This MOU does not create a joint venture, agency, partnership or other business arrangement, and any agreement between the parties as to business activities will be set forth in subsequent written agreements. Therefore this MOU cannot be used as a right to represent either party on behalf of the other, in any business promotion or sales activities, unless so authorized in writing.

13. Integration:

This MOU contains the entire understanding between the parties and supersedes any prior written or oral agreements between them.

14. Waiver

No failure or delay on the part of either party in the exercise of any right or privilege hereunder shall operate as a waiver thereof or of the exercise of any other right or privilege hereunder, nor shall any single or partial exercise of any such right or privilege preclude other or further exercise thereof of any other right of privilege.

15. Severability

If any provision of the MOU is held to be ineffective, unenforceable or illegal for any reason, such decision shall not affect the validity of any or all the remaining portions thereof.

16. Alternative Dispute Resolution

In the event of any dispute under this agreement, the same shall be amicably settled between the parties. If any dispute is not settled amicably, the same shall be referred to the sole arbitrator to be appointed by both the parties. The award given by the arbitrator shall be final and binding on both the parties. The language of arbitral proceedings shall be English. This arbitration shall be governed by the arbitration & conciliation act, 1996 and the place of arbitration shall be at Chennai.

17. Non-solicitation

During the terms of this MOU and for one year after its expiry or termination, neither party shall, without the prior written consent of the other party, canvass or solicit for direct or indirect employment of any employee (Involved with work of this MOU) of each other or proceed with any application by or on behalf of that employee for direct or indirect employment. Neither party shall procure any third party to do any of the aforesaid acts.

Memorandum of Understanding

This Memorandum of Understanding is entered on ___ day of _____ 2025 ("Effective Date") by and between **Edunet Foundation** having its office at 901, 9th floor, Unitech Commercial Tower - 2, Block B, Greenwood City, Arya Samaj Rd, Sector-45, Gurugram, Haryana 122003 (hereinafter referred to as "Edunet"); and

Rajasthan College of Engineering for Women
having its address Bhankota, Jhupur

_____ hereinafter referred to as "Institution")

WHEREAS Edunet is a non-profit organization with multiple programs, sponsored by government and corporate entities, that are offered free to learners across the education spectrum, including but not limited to the AI Careers for Women

WHEREAS Institution is a premier institution with the following details:

Established (year):	2002
Recognition, NAAC rating, ranking:	MAAC B+, AICTE, NBA
Vision:	Empowering Women Engineers.

AND WHEREAS, the Parties seek to collaborate with each other to mutually complement their synergies and to jointly work on building capacity of learners through one or more of the programs managed by Edunet.

NOW THEREFORE, this **Memorandum of Understanding** (hereinafter called "MOU") witnesses the following.

- 1. Term and termination:** This MOU is valid from the Effective Date till 31st July 2028. It can be extended by further periods, as agreed to by the Parties in writing from time to time. Either Party may terminate this MOU by giving the other minimum 30 days' notice in writing. The MOU will be deemed terminated at the end of the notice period or after completing all ongoing activities so that the beneficiaries (learners and teachers) are not negatively impacted, whichever is later. Neither party will be liable to pay any compensation to the other party in respect of expiry of term of or termination of this MOU.
- 2. Single Point of Contact (SPOC) for program co-ordination:** Both the Parties shall each appoint a suitable person who will serve as a single point of contact (SPOC) on all matters related to program rollout. Individual learners and teachers may be in touch with corresponding trainers, mentors,

advisors, and peers during program rollout, but all matters related to the execution of this MOU shall reside with the SPOC in accordance with the terms as agreed between the parties.

3. **Program Calendar:** The SPOCs from both Parties will work with their respective internal stakeholders to develop a calendar for the program(s) rollout at the start of every quarter. This calendar will then be synchronized and published for use by everyone.

4. **Responsibilities of Parties:** The following table outlines the responsibilities of both Edunet and the Institution towards this collaboration.

Establishment of AI Center for Excellence within the campus of the Institution	1. Appropriate premises with conditioned power, Internet access at workstation level, lighting, air conditioning and furniture will be provided by the Institution for the Center. Additionally, the institution will ensure that the requirements for lab establishment, as mentioned in annexure, are met. 2. A dedicated space for setting up the Center will be provided by the institution. 3. The maintenance and upkeep costs of the Center will be ensured by the institution. 4. The branding posters and signage from sponsors will be supplied to enhance visibility within the institution. The infrastructure thus created shall be transferred to the institution at the end of this MOU. Edunet will not be responsible for maintenance and upkeep of the same at any time though, once installed and commissioned. 2. Center commissioning will be handled by Edunet nominated personnel. 3. These Centers, once established, will serve as AI Center for Excellence for the following purposes: • Students Training: These labs serve as hubs for students training and hands-on learning, bridging the gap between academic knowledge and practical application. • Faculty Training: These labs would also be used for faculty training in emerging technologies. • Showcase event: AI Center for Excellence will be used by students to showcase their projects to industry relevant experts.

Learner identification and orientation sessions	mutual consultation with Edunet. 1. Institution will identify students and faculty who may participate in one or more programs offered by Edunet. 2. A minimum of 150-250 female learners (students in pre-final and final year only) will be identified by the institution, every year for the duration of this MOU, if required by Edunet Foundation, as recipients of the training program(s). 3. Institution shall manage the logistics related to the orientation sessions.	Edunet will conduct orientation sessions for learners and educators, at a mutually agreed schedule, to onboard them onto the program(s).
Program Materials	Institution will ensure that all materials received from Edunet Foundation and/or its partners are protected from intellectual property theft. Institution recognizes that the Intellectual property in all materials provided are the proprietary of Edunet and/or its partners and that there is no transfer of ownership of the Intellectual Property to the Institution.	Edunet will share all program materials with the institution and/or learners as required. All sharing will be online and/or through electronic media.
Classroom and/or online sessions	1. The institution will provide all on-the ground support for the conduct of sessions by the Edunet team. 2. The institution will publish, on a yearly basis, a program calendar for all its participants. 3. Institution will ensure that program participants enthusiastically participate in chosen programs, with minimum attendance of 80% as agreed between the Parties.	These sessions may take the form of webinars or mentoring workshops or technology bootcamps, or career readiness workshops that will seek to assist learners in their career goals. These programs will be organized regularly as per a regular calendar, published online, and will be conducted by Edunet team members or program sponsors or external stakeholders as appropriate.

3. **Non-binding nature of this MOU:** The MOU is not binding on either Party, and each is working with the other out of sheer good-will and for the benefit of the learners. The First Party & Second Party hereby establish a Memorandum of Understanding (MoU) with regard to a Women Internship Program (hereafter Internship Program) facilitating the First Party acceptance of students as Interns from Second Party.

About the Project

Rajasthan Secondary Towns Development Sector Project (RSTDSP), Phase-IV of RUIDP seeks to improve water supply and Sanitation (WSS) services in Secondary Town¹ and heritage towns with population between 20,000- 1,15,000 through a sector loan from Asian Development Bank (ADB).

¹ Secondary Towns means class 02 and class 03 cities

Details of the Internship Program

Internship Program is designed to allow women who have recently completed their studies or will soon complete their studies to gain valuable work experience in their respective technical fields and explore a career path in urban development, including the urban water supply and sanitation sector. Women from Scheduled Caste and Scheduled Tribes are encouraged to apply.

The internship would be of about 6-week duration in line with the typical internship requirement of the engineering colleges. The exposure gained during the six-week internship would give them an edge in the job market, a professional network, an opportunity to apply and gain new skills, confidence while starting their job search or deciding on further degrees to be pursued.

The students shall be engaged as per expertise and educational stream. RUDSICO-EAP has identified few key areas of engaging the students. Each Intern would be allocated a mentor at the time of induction in line with their respective field. She has to work under the direct supervision of mentor.

Location for Internship shall be 14 project towns of Tranche-I (Abu Road, Banswara, Didwana, Fatehpur, Khetri, Kuchaman City, Ladhun, Laxmangarh, Makrana, Mandawa, Pratapgarh, Ratangarh, Sardarshahar & Sirohi), 10 project towns of Tranche-II/Additional Financing towns (Balotra, Barmer, Bharatpur, Bundi, Dungarpur, Jodhpur, Nathdwara, Nimbahera, Nokha and Sagwara) and RUIDP HQ Jaipur or as decided by first party.

This is purely an internship program and does not provide any type of employment or guarantee for any employment in future.

Roles & Responsibilities of Parties

First Party-RUDSICO-EAP

1. Any expenses made for making a MoU a formal or legal document shall be made by RSTDSP.
2. Dy. Project Director (T) shall be the focal point for Women Internship Program.
3. A token lump sum honorarium shall be paid to each student by RUDSICO-EAP on completion of the 6-week internship. A total sum of Rs. 24000 (Twenty-four thousand) which will cover the cost of accommodation, transport, food and other basic logistics.
4. Each Intern would be allocated a mentor from PIU/PMU like Ex. Engineer or above of respective town at the time of induction in line with their respected field.
5. Internship Honorarium shall be paid on successful completion of the Internship period mentioned in the document and after submitting vetted final report by the mentor.

6. RUDSICO-EAP shall provide sitting/ workplace in PIU/PMU for the period of 42 days and shall provide office support expenses of stationery etc.
7. RUDSICO-EAP shall share the project data required in order to attain the desired outcome on interns.
8. For each batch, RUDSICO-EAP will organise a 1-day orientation session during the induction week to orient and familiarize the interns about the project and expectation during the Internship.
9. A completion workshop will also be organized with each batch of interns where the interns will present their work with key lessons learned and recommendations to further strengthen the project and the internship program. Interns will be encouraged to make the presentation at their respective schools too.
10. Apart from pre and post learning assessment, a test will be conducted at the time of completion workshop to judge the learning's of the interns in RSTDSP
11. Upon successful completion of the internship, RUDSICO-EAP will provide interns with a completion certificate.

Second Party-Colleges/ Universities/ Institutes

- a) The selection of students for Women Internship Program rests with the College/ University/ Institutes/ITI's. Women interns from scheduled caste and scheduled tribes will be encouraged to apply.
- b) The institutions will shortlist 5 (or mutually agreed number) meritorious women interns in the prescribed format and final decision. List of selected interns will be displayed on the website of RUIDP.
- c) Colleges/ University/ITI's shall refer the students on prescribed college letter head. Only those students who are recommended by college/ university on authorised letter head shall be considered for Women Internship Program.
- d) Colleges/ University shall appoint a senior teacher as focal point from college for coordination on Internship Program.
- e) College/University/Institutions shall provide college Identity cards to each student recommended for Internship program.
- f) College/ University/ITI shall take full responsibility of confidentiality of data, that no data shall be used other than academic purpose.
- g) College/ University shall take full responsibility for student's behaviour at the workplace and issue the following instructions in writing to students before Internship:
 - The Interns would work with their mentor to finalise a work plan/scope of work for the 6 weeks, ideally identifying the main output for the final report.
 - Additional tasks can be assigned to interns depending on need and interns' interests.
 - The interns can work at any of the all the project towns of RUIDP Phase-III & Phase-IV.

- Interns shall report daily to the allocated mentor and keep him in the loop of day-to-day activities.
- The intern shall maintain a daily timesheet and shall submit the approved Timesheet with the final report for obtaining an honorarium.
- Interns are expected to adhere to the code of conduct of the office and maintain the office decorum.
- Interns are expected to maintain the discipline in office and adhere to office timings.
- Interns should attend the office in formal attire.
- Interns should apply in the prescribed format.
